The ongoing challenges and administrative difficulties ATLMC has faced over the years have continued to increase and have become too numerous to navigate successfully. As a result, I am sad to report the doors of Atlanta Morning Center (ATLMC) clinic were officially closed as of 30 June 2025.

Since its opening in January 2022, scores of moms, babies, and dads have received compassionate, life-affirming Christ-centered care and services through ATLMC. Not only were babies saved but parents were spared the trauma inherent in an abortion decision.

Moms and couples surrendered to the Lordship of the Christ, and one couple got married before the birth of their precious child! Dads learned of and some affirmed their God ordained role as provider and protector.

As you are aware, the services offered by Team ATLMC included onsite prenatal medical care with a midwife, onsite ultrasounds and labs, child birthing classes, doula services, and adoption referrals to name a few. The most exciting and productive of the services provided was Journey of a Lifetime (JOL)® - perinatal palliative care and coordination for women and families that have received a life-limiting or other adverse pregnancy diagnosis.

**I am super excited to share that Journey of a Lifetime (JOL) has become its own autonomous, standalone, pro-life, nonprofit organization.**

The initial area JOL offered services included 9 southeast states: Georgia, Alabama, Mississippi, Louisiana, Arkansas, Tennessee, Kentucky, West Virginia, and Virginia. Shortly thereafter, our service area was expanded to include North Carolina, and South Carolina. Gaining national recognition, JOL has also

Dr. Haywood Robinson, LAS (my husband) a retired Family Medicine Physician of 47 years and the current Director of Medical Affairs and Education for 40 Days for Life, will serve as Director of Continuum of Care.

I received Parent Care Coordinator training in July 2022 and am eagerly anticipating resuming my training and eventually joining Heidi on the frontline as we serve JOL clients and families.
